Sub: Update on Acquisition

In accordance with the provisions of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we hereby inform you that the Company has signed the definitive agreements for the following transactions:-


- (1) for the acquisition by the Company of 28,09,66,752 (Twenty Eight Crore Nine Lakh Sixty Six Thousand Seven Hundred and Fifty Two) equity shares of Bhilai Jaypee Cement Limited ("BJCL") from Jaiprakash Associates Limited ("JAL") and its nominee for a total enterprise value of Rs. 1450,00,00,000 (Rupees One Thousand Four Hundred and Fifty Crores Only) subject to adjustment on account of working capital and net debt of BJCL ("Share Purchase"), which shall then be pro-rated to the shareholding of JAL in BJCL (i.e. 74%). The Share Purchase has been approved by the Board of Directors, subject to the requisite approvals of the shareholders of the Company in accordance with the Section 186 of the Companies Act 2013. The Share Purchase is also subject to compliance with applicable laws and receipt of relevant third party consents, as may be required.
- (2) for the acquisition by the Company of the Nigrie Cement Grinding Unit ("Business Undertaking") as going concern from Jaiprakash Power Ventures Limited ("JPVL") for a total consideration of Rs. 496,00,00,000 (Rupees Four Hundred and Ninety Six Crores Only) subject to adjustment on account of working capital and net debt of the Business Undertaking ("Business Transfer"). The Business Transfer is also subject to compliance with applicable laws and receipt of relevant regulatory/third party consents, as may be required.

The disclosure of events specified under Part A of Schedule III of the Listing Regulations is attached as Annexure.
